(57) **CLAIM**

The ornamental design for a dog house display case for novelty items, as shown and described.

DESCRIPTION

FIG. 1 is a right side perspective view of my dog house display case for novelty items;

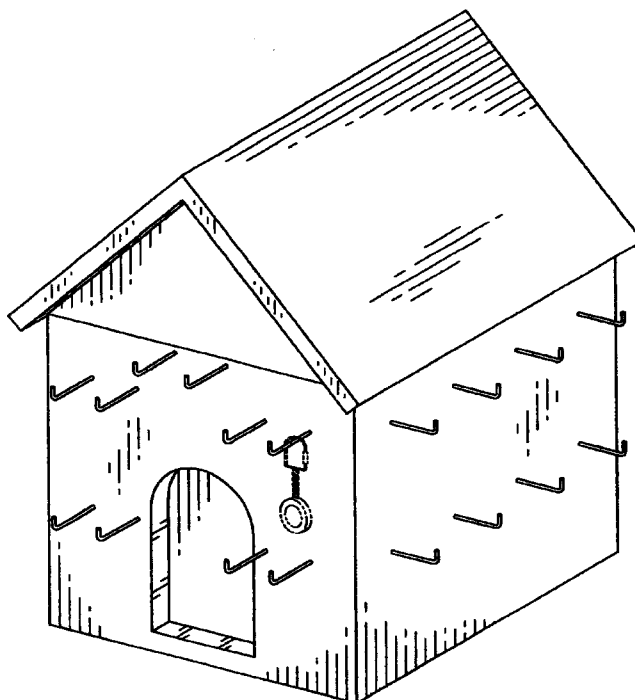
FIG. 2 is a front elevation view of my dog house display case for novelty items having a rear elevation view of identical design;

FIG. 3 is a left side elevation view of my dog house display case for novelty items having a right side of identical design; FIG. 4 is a top view of my dog house display case for novelty items; and,

FIG. 5 is a bottom view of my dog house display case for novelty items.

The broken line showing of a base in FIGS. 2, 3 and 5 is for illustrative purposes only and forms no part of the claimed design.

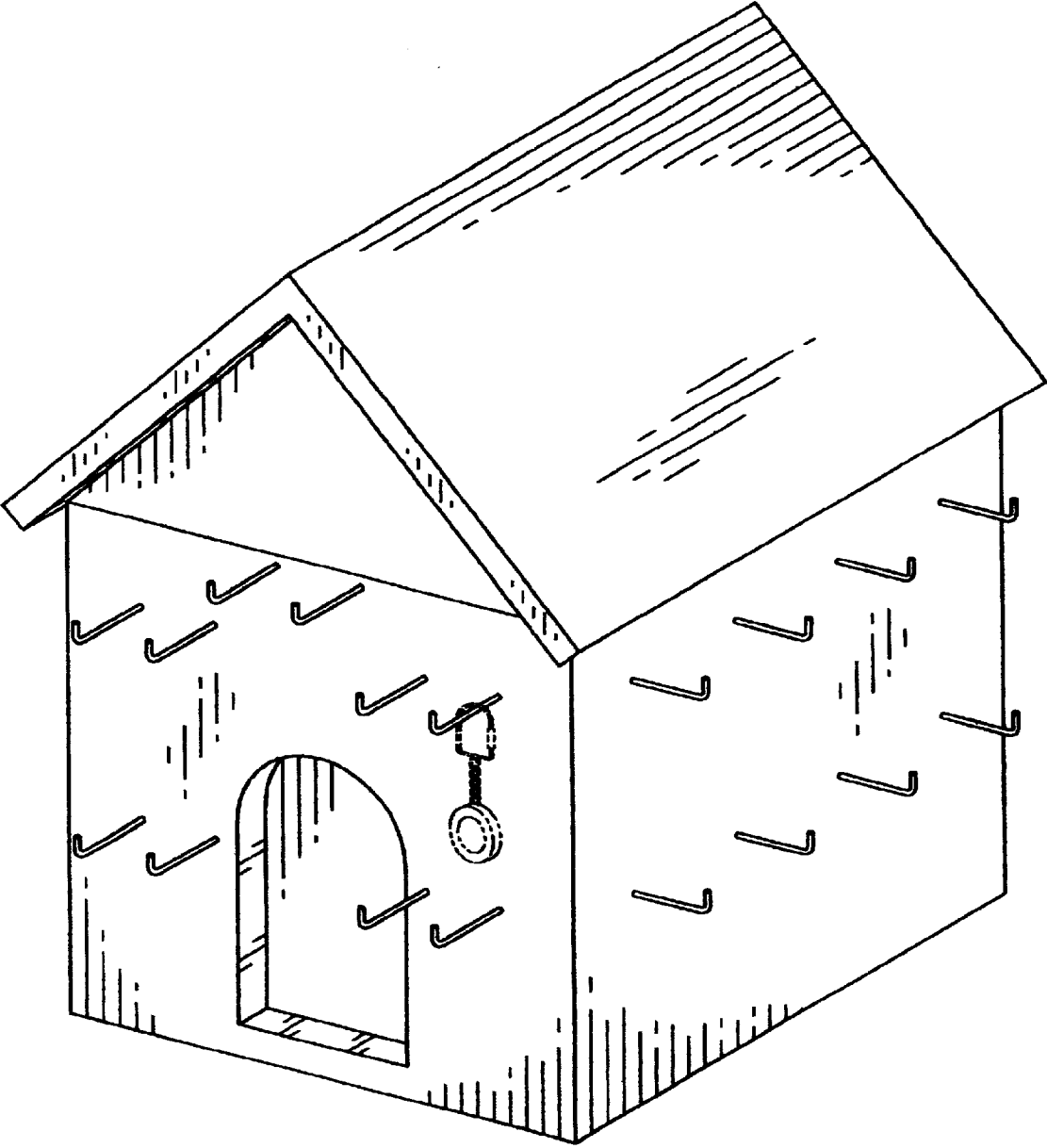

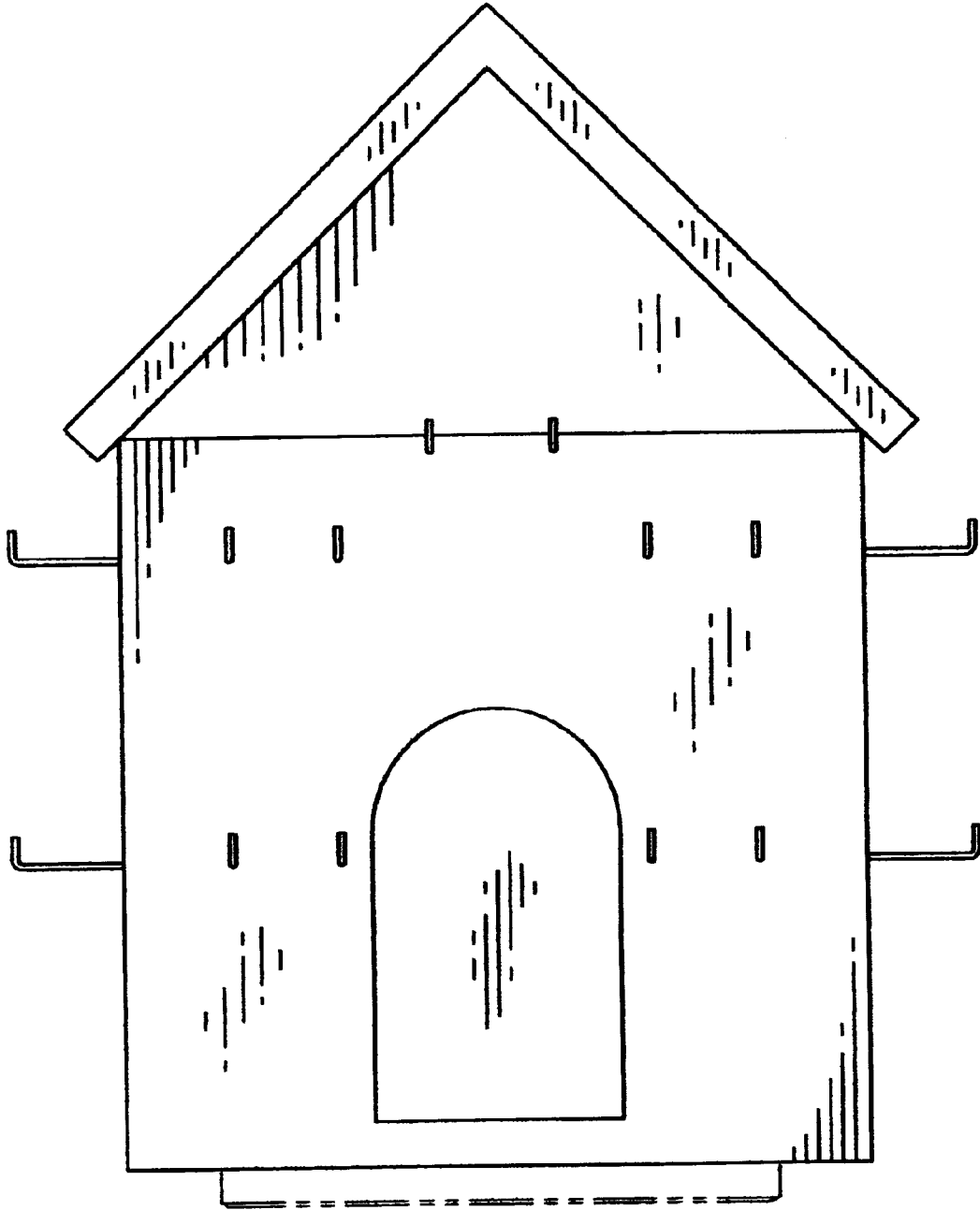

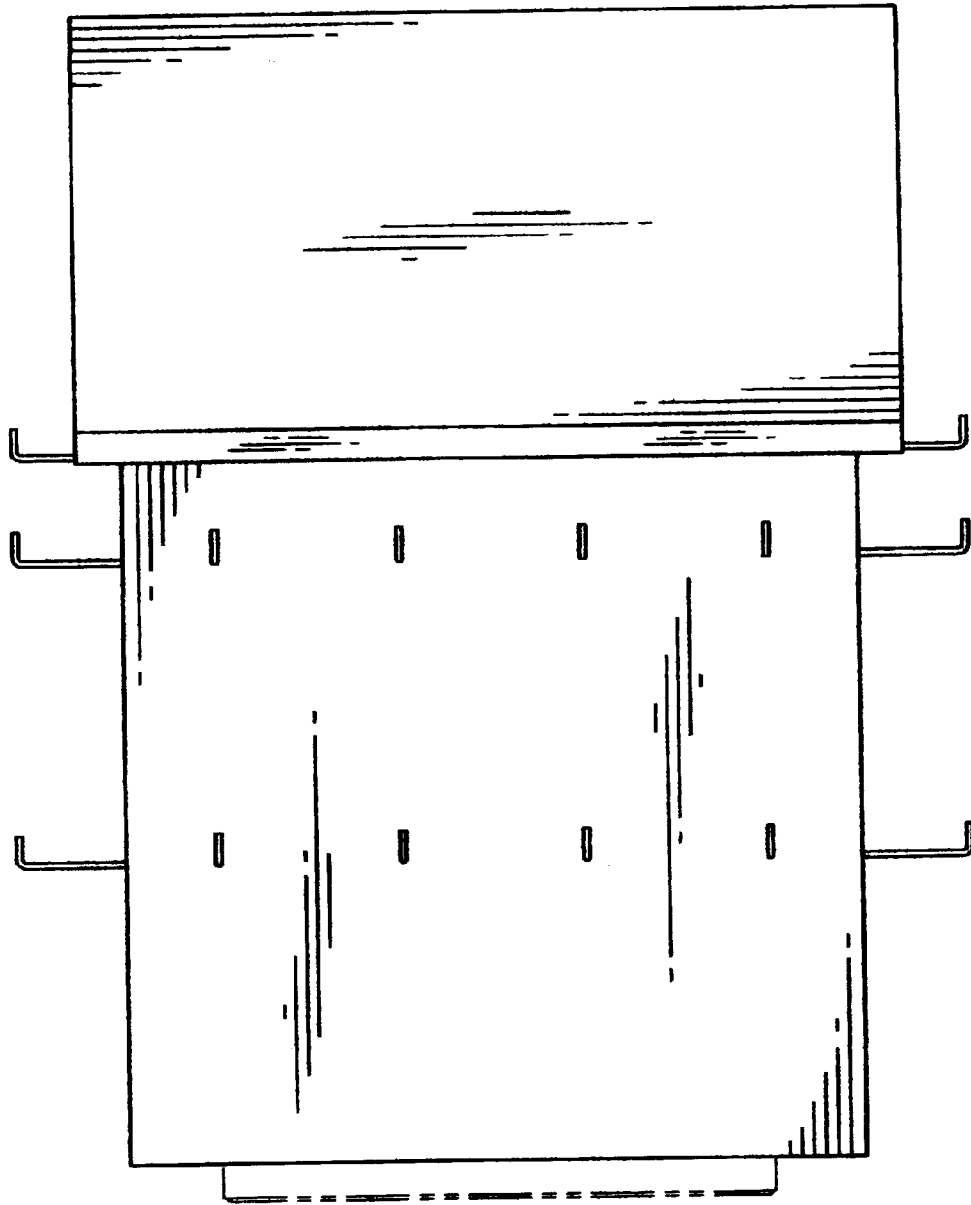

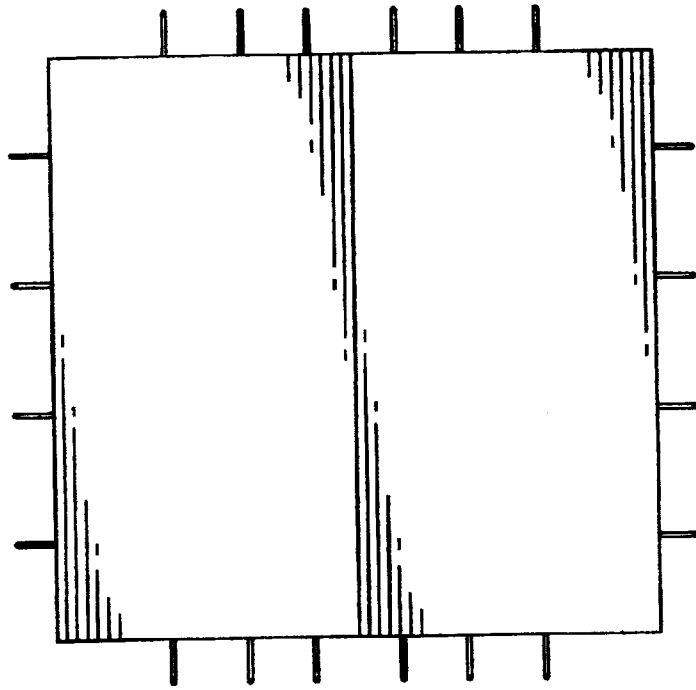

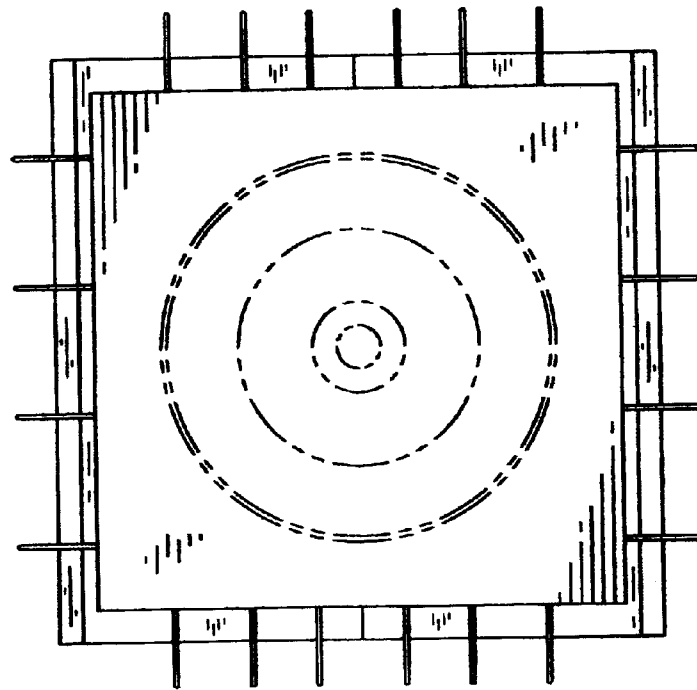
